Motion carried 5-0.

APPROVAL OF RESOLUTION AWARDING THE SALE OF GENERAL OBLIGATION SCHOOL BUILDING BONDS, SERIES 2016A: Joel Sutter, Ehlers and Associates, the district's financial adviser, reported on the bid results of the bond sale. He said low interest rates will reduce the tax impact of the new school construction for taxpayers in the Moorhead Area Public Schools.

In December, the School Board approved the sale of general obligation school building bonds. Bonds with a principal amount of \$74.6 million sold at 2.78 percent interest, in part because of the district's Aa3 rating from Moody's Investors Services. Seven bids were received, and the School Board accepted the low bid from Bank of America Merrill Lynch, New York.

Sutter said the total principal and interest over the life of the bonds will be almost \$18 million less than what was estimated last summer. Ehlers and Associates used a conservative 4.2 percent interest rate for estimates prior to the district's Nov. 3 bond referendum. Those estimates called for taxes to increase \$105 annually on a home valued at \$150,000.

The tax impact for taxes payable in 2016, which was set in December based on estimates, will be less than the estimate provided prior to the November 2015 election. A home valued at \$150,000 will see an increase of \$96 annually, a decrease of \$9 for taxes payable in 2016.

The tax impact for 2017 decreases further as a result of the low interest rate. A home valued at \$150,000 will see an increase of only \$79 annually, a reduction of \$26 less than estimates prior to the election.

For taxes payable in 2017, agricultural land valued at \$5,000 an acre will see an increase of only \$3.13 an acre annually, a reduction of \$1.03 an acre less than estimates prior to the election.

The bonds will finance the construction of a K-4 elementary school and a grades 5-6 addition to Horizon Middle School and renovation projects, including upgrading and constructing secure entrances, at other district sites.

Fagerlie moved, seconded by Johnson, to approve the resolution awarding the sale, determining the form and details, authorizing the execution, delivery, and registration, and providing for the payment of the general obligation school building bonds, series, 2016A. Motion carried 5-0.

<u>APPROVAL OF INVESTMENT ADVISORY AGREEMENT</u>: Lunak explained the resolution giving authority and responsibility to invest and manage excess building bond funds to PFM Asset Management, LLC on behalf of Moorhead Area Public Schools.

Fagerlie moved, seconded by Altenburg, to approve the resolution for investment of excess funds giving authority and responsibility to PFM Asset Management, LLC. Motion carried 5-0.

APPROVAL OF FISCAL YEAR 2016 REVISED BUDGET, FISCAL YEARS 2017, 2018 and 2019 PROJECTED BUDGETS: Lunak reviewed the district's revised fiscal year 2016 budget and projected fiscal year 2017, 2018 and 2019 budgets. Revenues were decreased by \$1.7 million due to change in when property tax is received; decrease in teacher development and evaluation state aid (one-year commitment); and a more conservative adjustment of special

education based on FY2015 audit results. Revenues increased \$44,592 for participation fees, out-of-state tuition and third-party billing revenue. Expenditure increases of approximately \$3 million include administrative expenditures; regular and vocational instruction and pupil support due to an increase in student enrollment; and capital outlay due to increase in technology, classroom setup costs, parking lot improvements, JDP building setup, and PCE remodel.

According to current projections, the district is projecting expenditures to exceed revenues by approximately \$1.5 million for fiscal year 2017, \$233,361 for fiscal year 2018 and \$2 million for fiscal year 2019.

Discussion was held related to projected fund balances and the need to be conservative.

Valan moved, seconded by Fagerlie, to approve the Fiscal Year 2016 Revised Budget as presented. Motion carried 5-0.

FIRST READING OF POLICIES: The board conducted a first reading of policies, Instruction and Curriculum Advisory Committee 231, Community Education Advisory Council 237, Staff Development 446, Curriculum and Instruction Goals of Moorhead Area Public Schools 601, Title I Policy Governing Comparability 606, Inclusive Educational Program 609, Relationship Between Nonpublic Educational Organizations and Moorhead Area Public Schools 920, and Community Education 930.

SCHOOL DISTRICT FACILITIES UPDATE: Lunak reported the Michael J. Burns Architect group would provide an update on the remodeling projects at the first or second board meeting in February.

<u>COMMITTEE REPORTS</u>: Brief reports were heard related to the Policy Review Committee, Early Childhood Family Education Advisory Committee, Moorhead Schools Legacy Fund Committee, Staff Development Committee, and Instruction and Curriculum Advisory Committee meetings and the Clay County Joint Powers 47th Annual Intergovernmental Retreat and MSBA Annual Leadership Conference.

OTHER PERTINENT ITEMS TO COME BEFORE THE BOARD: Lunak noted the January 26 Activities Advisory Council meeting was canceled.
