Fiber/Dark Fiber: Potential bidders MUST refer to the RFP for specifications and requirements. We wish to compare Lit Services and Dark Fiber services for the completion of the district Wide Area Network (WAN). The current WAN connects eight school entities to the High School via 4 strands of dark leased fiber. This RFP requires connecting two additional sites. We are seeking two options for bids. Respondents may bid on either or both options. The first is a fully managed lit fiber service WAN to the two locations. The second option is for a leased dark fiber solution that includes special construction costs, the monthly lease fee, as well as any recurring maintenance, and operational fees. There is a very specific timeline listed in the RFP. Bids must be submitted in sealed envelope and received by 2PM on April 6, 2016 at Probstfield Center for Education, ATTN: E-RATE WAN RFP response;2410 14th Street S; Moorhead, MN 56560. Emailed responses will not be accepted. Respondent's submittals MUST include a completed WAN RFP Pricing Response Worksheet. Option 1 Lit Service: 10GBPS with Service Level Guarantees between designated endpoints. SEE RFP. Option 2: Leased Dark Fiber: 2 pair (4 strands) of single mode fiber between the designated endpoints. Maintenance services, equipment purchase, installation and management are requested. As per the 2016 Eligible Services List, "modulating electronics and other equipment necessary to make a Category One broadband service functional are considered Category One services.
