### TRANSPORTATION CONTRACTS FOR 2017-2018 AND 2018-2019 SCHOOL YEARS:

Brandon Lunak, assistant superintendent of finance and operations, and Dan Bacon, director of transportation, briefly reviewed the student transportation contracts. The contractor supplies and maintains the number of school buses and personnel required to fulfill the district's need for pupil transportation services.

Steffes moved, seconded by Fagerlie, to approve the student transportation contracts with Richards Transportation, Red River Acquisitions, and Schuck Bus Services for the 2017-2018 and 2018-2019 school years with an option to negotiate extensions to the contract. Motion carried 5-0.

**EARLY MIDDLE COLLEGE:** Deb Pender, director of alternative programs, Janel Simonson, school counselor at Red River Area Learning Center, and Maronda Robertson and Tom Dubbels, counselors from Minnesota State Community and Technical College, provided an update on Moorhead's Early Middle College program after completing one year of implementation.

The Minnesota Department of Education defines the Early/Middle College program as a high school program that allows a pupil to earn a high school diploma while also earning postsecondary credits toward a degree or credential including a certificate, diploma or an associate's degree. An Early College Program is a high school program that allows a pupil to earn a high school diploma while also conferring a certification, associate's degree, or up to two years of credit toward a bachelor's degree. Early/Middle College Programs are designed to serve students in the academic middle — especially low-income, English language learners, first generation college students, and/or students of color.

Students are considered eligible if they are enrolled in a core school day State Approved Alternative Program (SAAP) under the graduation incentives program as defined by the Minnesota Department of Education. The program must meet criteria to be determined as an Early or Middle College Program with eligible participants as defined above.

<u>UPDATED DISTRICT AND SCHOOL PROFILES</u>: Missy Eidsness, assistant superintendent, briefly reviewed updates to the 2015-16 District and School Profiles, which will be updated in October and the spring each year. The majority of data in the School Profiles is updated in October. This includes district and school demographics, enrollment, student achievement and human resources data. Each spring, graduation, mobility, and remaining demographics and achievement data will be updated. Graduation rates are released each February by the Minnesota Department of Education for the previous spring's graduating class.

Steffes moved, seconded by Bjorklund, to approve the updated 2015-2016 District and School Profiles. Motion carried 5-0.
